3. Ordinance No. C2018-8; Bench Warrant Fee Ordinance

Several cities in New Mexico have adopted a bench warrant fee that mirrors the bench warrant fee that is imposed by magistrate courts. When defendants don't appear for court, there is a substantial cost to municipal court and police department personnel in processing the paperwork associated with issuing the warrant, arresting the defendant, booking him/her into jail, and resetting the case for hearing. This ordinance attempts to offset that cost by imposing a fee on the defendants who have caused the problem.

The ordinances around the state differ in how the funds are dispersed. Some put all of the money into the court's budget, some split it between the court and the police department, and some put it into the general fund. The discussion with the police department and the municipal court resulted in a decision that we should

initially deposit the funds into the general fund until we have a sense of how much revenue is being generated by the fee.

Fiscal Impact: Unknown. Additional revenue will be generated by the fee but the amount is unknown.
Recommendation: Adoption of the proposed ordinance.

4. **Additional Engineering Support - Grandview Tank Rehabilitation Project**

The City issued Purchase Order (PO) 078676 for \$179,896 to DePauli Engineering Services (DES) in December 2013 for the design and construction oversight of the Grandview Tank Rehabilitation Project from Fund 202. The contract with Paso Robles Tank Company (PRT) listed a final completion date not to exceed March 25, 2018. Due to a number of issues with the Contractor, this date was exceeded, and liquidated damages in the amount of \$500 per day have been accruing.

The costs for engineering and construction oversight services would have come in under budget had PRT met its milestones. However, due to the overrun in schedule, the original engineering services budget has been exceeded. Utilities Staff requested a cost estimate from DES for the additional work to complete the project. Attachment 1 is the Cost Proposal submitted by DES.

These additional costs will be offset by liquidated damages assessed to PRT, along with a potential claim against PRT's performance bond.

The Project has a remaining balance of \$1,511,450 left. Requested Council action is to increase the current PO by \$76,439 using available funds left in the project.

Fiscal Impact: \$76,439 outflow from Fund 202. Please note that City intends to file claim against contractor for this amount. In addition, liquidated damages against contractor have been accruing at a rate of \$500 per day since March 25, 2018.
Recommendation: Staff recommends approval of increase of \$76,439 to current PO.

5. **Award Trenching Contract For Churchrock Street Extension Lighting Project**

The City of Gallup has received a proposal from Cooperative Educational Services based on a proposal from Murphy Builders for trenching and conduit installation for the Churchrock Extension Lighting Project. This project involves installation of 27 LED street light fixtures on both sides of Churchrock from Vanden Bosch Parkway to Rehoboth Drive and requires the installation of approximately 8,100' of conduit.

This project was funded at \$115,000 in the FY 2018 budget (Account 507-6061-

442.48-90). After completion of design, the total cost of the project is \$125,000. We are requesting that the original \$115,000 and an additional \$10,000 of unencumbered funds from the same account (507-6061-442.48-90) be transferred to Fund 307 for a total project budget of \$125,000. The anticipated completion date is September 30, 2018.

Fiscal Impact: The proposed contract price of \$55,478.15 is within the budget for this project.

Recommendation: Staff recommends that the contract be awarded to Cooperative Educational Services for \$55,478.15

6. Construction Contract Award For Octavia Fellin Public Library ADA Ramp Upgrade Project

Discussion: Bids were open on 8 May 2018 for the subject project. Longhorn Construction of Albuquerque, NM was the apparent responsive low bidder at \$63,579.44 including NMGRT.

Architect Of Record is Huitt-Zollars of Albuquerque, NM. Scope of work consists of rebuilding the front entrance of the Octavia Fellin Library and associated wheelchair ramp to ADA standards.

Fiscal Impact: \$70,000 project budget increase for construction costs. Funding is available in Risk Management Fund 603.

Recommendation:

1. Approve \$70,000 budget increase (including 10% for project incidental expenses) from Fund 603 for the subject project. Additional funding will be transferred into the capital project fund.
2. Award the construction contract to Longhorn Construction of Albuquerque, NM in the amount of \$63,579.44 including NMGRT.

8. Resolution No. R2018-16; A Resolution Establishing A New Fee Schedule At Fox Run Golf Course

Comprehensive research was used to determine the best rates/fees for Fox Run Golf Course. Municipal courses through out the state were contacted to determine the best price association for course conditions. Municipal numbers on a national level were also taken into consideration for the rates/fees determination. The best solution offered is to offer a year one rate effective July 1st, 2018 and would end March 31st, 2019. The permanent rate would take effect April 1st, 2019 and would last until inflation or future cost exceed current pricing scheme. The year one rates allow the course to open sooner, because they are reflective of course conditions. The rates can be found on the attached document.

Fiscal Impact: The fiscal impact is dependent upon rounds of golf. Achieving 20,000 rounds of golf in year one could potentially gross \$500,000.

9. Resolution No. R2018-17; A Resolution Amending The Usage Policy And Fees At Red Rock Park

On September 26, 2017, the Gallup City Council adopted Resolution No. R2017-23, which amended the usage policy and fees at Red Rock Park. Following adoption of the resolution, staff realized that it would be beneficial to offer incentive discounts for consecutive long-term events. Staff is proposing a discount at 5 years=10%, 10 years=20%, and 15 years or more=30%.

Fiscal Impact: TBD as the City collects revenue for use of Red Rock Park.

10. Summer Youth Program Budget Adjustment

In the fall of 2017, the City of Gallup received word that they would not be awarded the Youth Conservation Corps (YCC) grant. Staff from the City and County got together to see if there was a way to still offer youth employment during the summer. Due to the funding cycle, the city budgeted matching funds for the 2018 season. Budgeted funds plus \$20,000 from the County will allow us to keep this very important youth program going for the summer. In addition to the \$20,000 from the County, the City also received \$20,000 for tasks completed in the summer/fall of 2017 by the YCC program.

Fiscal Impact: Budget increase of \$40,000. This budget adjustment will budget revenue, expenditures and allow for McKinley County contribution for tasks performed or expenses directly related to the scope of work for projects.

Recommendation: Staff recommends approval of the budget adjustments.
